## Introduction

This document describes the features and functionality of the Siterra 23.3 release. Enhancements have been made for the following components: **BOU**, **Elastic Search**, **Import**, **Payments**, **Permissions**, **Project**, and **SSO**.

## Enhancements and Issues Resolved

BOU	SP-50915	In <b>Subtasks Extension</b> , when you select a form type subtask, <b>Standard Attributes</b> of all object types now also appear for viewing and editing.
BOU	SP-51505	Rejecting an approval subtask <b>Subtasks Extension</b> in BOU now triggers a task rejection workflow.
BOU	SP-51579	We added a new Input/Import functionality for <b>Subtasks Extension</b> that allows users to filter project numbers in BOU.
BOU	SP-51580	Instead of the EA name for <b>Subtasks Extension</b> , the EA <b>Label</b> name now appears when available.
BOU	SP-51804	<ul style="list-style-type: none"> <li>We added a new permission set under <b>Global Permissions – BOU &gt; Project Task &amp; EA data</b> and <b>BOU &gt; Subtasks Extension</b>. You can now give access to <b>BOU Extensions</b> based on role permissions.</li> <li>We added a new menu in BOU with <b>Project Task &amp; EA data</b> and <b>Subtasks Extension</b> options.</li> </ul> <p>The users who had access to BOU before will by default have access to both flows.</p>

BOU	SP-51961	<ul style="list-style-type: none"> <li>In both flows, we changed the column heading <b>Serial Number</b> to <b>Sr. No.</b></li> <li>In the default flow, we removed the <b>Extended Attributes (EA)</b> heading to break banned columns. You can now rearrange and freeze any EA column.</li> <li>To filter multiple projects, you can now enter a string of numbers on the <b>Project Numbers</b> columns by selecting the <b>Contains</b> filter on the column level.</li> </ul>
BOU	SP-52177	In the grid, you can use the new <b>Clear all filter</b> icon to clear all column-level filters and column freeze.
Elastic Search	SP-49241	We fixed an issue that caused <b>Elastic Search</b> to return objects that were not relevant.
Import	SP-51464	We fixed an issue that caused the CSV import schema for <b>Incidents</b> to throw an error if there are many assigned users.
Payments	SP-47461	The escalation that starts on February 28 of a leap year now creates an incremental line to a paid/canceled payment line that ends on the start date of the escalation.
Payments	SP-51634	The maximum character limit for the <b>Lease Payments Reference Number</b> is set to 30 for all sources.
Permissions	SP-51787	<p><b>Project Update Status</b> is placed in <b>Edit project header information permissions</b>, under <b>Manage permissions</b>.</p> <p>If you do not have access to the <b>Edit project header information</b>, you will not be able to view the <b>Update status &amp; edit option</b> on the project page.</p>

Component	Reference	Summary
Project	SP-49858	When you update the status of a project via forms, you can now view the changes in <b>Status Log</b> .
SSO	SP-51624	SSO users no longer get an account expiration notification.
